- 3. Delivery timeline (latest by: insert date).
- 4. Indication of whether you are a Manufacturer or Distributor.
- 5. Certificate of authenticity if you are a distributor for any specific brand.
- 6. Any additional sponsorship your company can offer if selected.

#### **DELIVERY & SUBMISSION CONDITIONS**

- 1. Samples provided shall not be returned.
- 2. SCA may choose to accept delivery in multiple consignments.
- 3. In the event that SCA agrees to a partial shipment, the quantity should not be less than 400 red balls and 150 white balls.
- 4. Final product quality must match the submitted sample.
- 5. SCA reserves the right to accept or reject any tender without assigning reasons.
- 6. Late submissions will not be considered.

### **TERMS AND CONDITIONS**

- 1. The vendor will be required to provide the company's track record and relevant experience in delivering the required product/service.
- 2. The vendor will provide all services/products as stated in the above specifications and quotation submitted before the closing of the Invitation to Quote.
- 3. The evaluation of the quotation will be based on price competitiveness, track record and relevant experience.
- 4. Upon successful award, SCA will issue a Purchase Order to initiate delivery of the goods/services.
- 5. In delivering the product/services, the vendor will comply with all the governing laws related to the product/services.
- 6. It is the responsibility of the vendor to issue an invoice to facilitate any payment that is made.
- 7. The vendor will allow SCA for up to fourteen (14) days to process payment.
- 8. A Variation Order (VO) of up to 20% of the amount awarded may be allowed should there be a requirement to reduce or add-on purchases.
